



General Information

1. Applications that are incomplete or that do not provide verification of address and/or family income will not be accepted.
2. Participants must be residents of the City of Modesto. Residents of other Stanislaus County Cities and other unincorporated areas within the county may residents may also qualify.
3. Applicant's age will be subject to verification via a copy of the child's original birth certificate.
4. Any funds unused by the applicant will be forfeited if not used by the cards expiration date.
5. Approved applicants will be awarded Leisure Buck ID cards to use when registering for classes or City-Approved co-sponsored sports leagues.
6. ID cards are non-transferable and applications must be renewed annually in July.
7. Awards will be issued on a first come first served basis as long as funds are available and program funding allows.
8. Any fees exceeding the \$50 limit will be the responsibility of the participant or his/her parent(s).

Financial Assistance Information

The Youth/Senior/Disabled Recreational Financial Assistance Program is for any individual wishing to participate in a City of Modesto Parks, Recreation and Neighborhood Program or in a City approved Youth Sport League. Participants must be 18 years of age or younger, or 62 years of age or older and meet the financial eligibility requirements listed.

Approved applicants will be eligible for a maximum award of \$50 per fiscal year (July 1 – June 30) to be used as stated above. Financial assistance will be granted to pay up to 90% of registration fees for programs that cost \$5 and above. Participants will be required to pay the remaining 10% at the time of registration.

Eligibility Requirements

- A. Families must live within the City limits of Modesto. Or in a qualifying Stanislaus county city or area.
- B. Families living in a low-income target neighborhood within Modesto city limits, as designated by HUD, will automatically qualify. A list of streets in low-income target neighborhoods is printed on the reverse of the application. A copy of an ID, which shows proof of residency, must accompany the application. See application for acceptable forms of ID.
- C. Families receiving TANF (Temporary Assistance for Needy Families) will automatically qualify for financial assistance. A current income verification from your caseworker must accompany application. Notices of action must be dated within 30 days.
- D. Families not receiving TANF nor residing in low-income target neighborhoods must show proof that the family/household income is at or below current HUD low-income guidelines. Applicants or parents of applicants must provide proof of annual income by submitting the most recent year's tax return and pay stubs, social Security benefits statement (SSA 1099) and/or Supplementary Security Income. Banks statements with a direct deposit listed as a source of income are *not acceptable*.
