**City of Modesto Citizens Salary Setting Commission
2026-2028 Initial Recommendation**

Background / Context

The City Charter establishes the limits of compensation for City Council Members and Mayor. The Citizens Salary Setting Commission, composed of five (5) members, was appointed to determine the extent the salaries should be increased, if any. This commission, as required by the City of Modesto Charter Section 703(b), met “between March 1 and April 30th of every even numbered year.” Through Measure M, the five members shall be qualified electors residing within the City and appointed by the City Council, serving without compensation. Qualifications of the current commission include:

- A member from a bona fide local nonpartisan political organization with tax exempt status
- A former member of the Civil Grand Jury
- A member of a bona fide local taxpayer’s association with tax exempt status
- Two members who have demonstrated civic involvement and a capacity to serve in an honest, independent, and impartial fashion

In 2024, the Commission made the following recommendations:

- Increase the Mayor’s salary from \$43,200 / year to \$54,000 / year.
- The Mayor received a 25% salary adjustment increase based on CPI from 2008 to 2024.
- Increase the Council Member’s salary from 24,000 / year to \$30,000 / year.
- The Council received a 25% salary adjustment increase based on CPI from 2008 to 2024.

The Citizens Salary Setting Commission makes recommendations using these parameters set forth by the City Charter:

- The recommendation is not an evaluation of the current officeholders, but rather to determine fair compensation for the responsibilities of the office itself.
- The compensation limit for a **City Council Member** is half (**50%**) of the median family income (currently at **\$79,891**) for the Modesto Metropolitan statistical area as reported by the United States Census Bureau.
- Council Member current salary: **\$30,000** per year.
- The compensation limit for the **City Mayor** is half (**50%**) of a Stanislaus Superior Court District Judge (currently at **\$248,368**).
- Mayor current salary: **\$54,000** per year.
- Salaries are paid out of the General Fund of the City Expenses.

Guiding Principles Considered

Several principles guided this Commission and their recommendation:

- **Public Responsibility:** Compensation should remain modest and respectful of taxpayer resources.
- **Workload Reality:** Although these positions are described as part-time, actual responsibilities often include:
 - Council meetings
 - Preparation and review of agenda materials
 - Committee Assignments
 - Regional board participation
 - Constituent meetings
 - Community events

Analysis

The current Commission met a total of five (5) times since the initial orientation meeting on February 27, 2026, to discuss and analyze data requested from and provided by City of Modesto staff. The methodology included the following:

- Current Salary of the Stanislaus Superior Court Judge, median household, and Modesto full-time wage earner
- Current Population of Modesto, Modesto Expenses, and updated Comparable Tables
 - San Joaquin Valley Cities
 - Charter Cities
 - Expenses and Population
- CPI increase from 2024 to present
- Role of Mayor as full-time and part-time
- Other official duties including committee assignments
- Both the Mayor and City Council Members have fringe benefits that are limited in scope.
- Both the Mayor and City Council Members may participate in the City’s health plan at their own expense.

Findings

Note: Modesto’s population has been flat, median household income is up approximately 9%, personal median income is flat. CPI has risen by 5.4% since 2024.

Note: A Salary review of Comparable Cities by Population, Expenses, and Mayor position of Full or Part Time found higher salaries for Full Time Mayors, lower salaries for Part-time Mayors. The salary for Full Time ranges from San Bernardino at \$50,000 to Sacramento at \$184,654. The salary for Part-Time Mayors ranged from Huntington Beach at \$22,805 to Modesto at \$54,000. Within the comparable cities the Modesto Mayor is paid more than San Bernardino Full Time Mayor and is the Highest paid Part-Time Mayor. Salaries are only paid out of the General Fund for the City of Modesto, which for 2026 is projected to be \$206,449,484.

Note: *On review of Comparable Cities by Population, Expenses and Mayor position, the Commission found that Cities with Full-Time Mayor structure had higher salaries for the Council Members. Berkeley at \$90,954 and San Bernardino at \$40,728. Cities with Part Time Mayors had lower salaries; Sunnyvale the highest at \$38,307 and Modesto Council Member’s salary at \$30,000. The salaries are only paid out of the General Fund for the City of Modesto, which for 2026 is projected to be \$206,449,484.*

The rationale for this recommendation:

The office of Mayor and Council Members choose to run for the office because they desire to serve and improve our community by making a positive impact. Through their service they become the voice of their constituents.

After our review of the data from several data points, our recommendation is to increase the respective salaries by 6.2% after considering CPI (5.4%) and Median Household (9%).

APPENDIX

Glossary of Terms

CPI: CPI stands for Consumer Price Index, a measure of inflation. It tracks inflation by the average change in prices paid by consumers for goods and services. CPI gauges the cost of living and purchasing power of money.

Charter City: Modesto is a Charter City, it operates under its own charter, which is our local constitution. Charter Cities can establish their own laws and regulations, particularly in areas like taxation and land use. A Charter or changes to a Charter requires the local vote by residents. There are 125 cities in California that have adopted Charters.

General Law City: Operates under the general laws of California, rather than a city charter. It is governed by the California Government Code, which outlines its powers and responsibilities. General Law Cities have limited flexibility compared to Charter Cities.

City Manager: Serves as the chief executive officer of the city, overseeing daily operations of all the departments within the city. They are responsible for implementing city policies and managing municipal departments. The city manager develops and proposes budgets, and financial updates. Engages with residents to address concerns and gather feedback. Leads emergency response efforts and public safety initiatives.

Full Time Mayor: Typically found in large cities, they are full time, they dedicate their entire time to overseeing city operations, leading initiatives, and managing staff. Their role is involved in daily governance and budgetary oversight.

Part Time Mayor: Typically balances their duties with other employment. The City Manager oversees the day-to-day operations of the city. The Mayor is the ceremonial lead for all political and representative purposes, and by the Governor for military purposes. The Mayor makes recommendations to the City Manager on policy, programs; and can request budgetary information. They do not hire or evaluate staff.

Household: A household includes all the people who occupy a housing unit (such as a house or apartment) as their usual place of residence. A household can consist of family members, roommates, or unrelated individuals. A household is often responsible for shared expenses like rent, utilities, and groceries.

Median Household Income: This income level represents the middle-income of a household in an area. Half of the households earn more than the median, and half earn less. It is often used to gauge economic health and living standards of a city.

Per Capita Income: Per capita income measures the average income earned per person in a specific area. It is calculated by dividing the total income of a region by its population. This metric helps assess the economic health and standard of living in a city.
