Parking vouchers will be made available for in-person participants. *If you choose to attend the meeting in person, you will be required to wear a face covering. Please note, Spanish interpretation is available ONLY for those individuals who are participating in-person.*

Joining via YouTube (Watch Only)

To use Zoom, please visit: <https://zoom.us/> and either sign-up for a free Zoom account or continue as a guest. Once you have downloaded the app onto your mobile device, joined from your web browser, or downloaded the Zoom software on your computer you will be ready for the upcoming meeting.

Joining the meeting via Telephone

If you don't have a smart phone or computer to access the meeting via Zoom, you can participate by phone, by calling 1-877-853-5257 (Toll Free) or 1-888-475-4499 (Toll Free) and enter the Webinar ID 850 3840 6726 Passcode 84326

Providing Public Comment on Zoom and by Telephone

USING A COMPUTER OR SMART PHONE APP:

- Click on the "Raise Hand" feature in the webinar controls. This will notify City staff that you have raised your hand.
- City staff will unmute your microphone when it is your turn to provide public comment.
- A prompt will appear to confirm you would like to be unmuted and then you will have up to three minutes to provide public comment. The time allowed for your public comment will depend on the number of people wishing to speak during the allotted time.
- Once your public comment has ended, you will be muted again.

USING A REGULAR PHONE (not using a computer or smart phone APP):

- Dial *9 (star 9), this will notify City staff that you have "raised your hand" for public comment.
- City staff will unmute your microphone when it is your turn to provide public comment.
- You will hear "you are unmuted" and then you will have up to minutes to provide public comment. The time allowed for your public comment will depend on the number of people wishing to speak during the allotted time.
- Once your public comment has ended, you will be muted again.
- If your phone is unmuted, and you are unable to be heard, the host may ask that you Dial *6 to toggle mute on/off in Zoom.
