Notice is hereby given that the City of Modesto encourages residents to apply for positions on City Boards, Commissions and Committees that will have vacancies in 2026.

At the end of each year the City posts a list of expiring appointed terms for the coming year, names of incumbents, and the dates of their appointment. AIRPORT ADVISORY COMMITTEE (4-Year Term)

The Airport Advisory Committee is responsible for advising on policy matters pertaining to the operation and management of Modesto City-County Airport, the uses of property adjacent to the airport if such uses may impact operations at the airport, and any other matters as the City Manager or Modesto City Council may request relating to the Modesto City-County Airport. The Airport Advisory Committee makes recommendations regarding plans and policies for airport safety and assists in the preparation of the Airport Master Plan, Airport Capital Improvement Plan, and other related plans and documents.

Membership Requirements: Members are required to live within Stanislaus County and the roles for each position are: Public At Large, General Aviation Small Aircraft Owner, Corporate Aircraft Owner / G.A., Commercial Carrier / Service Provider, Small Aircraft Owner / G.A., Business Owner / Service Provider, Supervisor & Non-Voting Member, Councilmember & Non-Voting Member, Non-Voting Member

AUDIT COMMITTEE (4-Year Term)

The purpose of the Audit Committee is to advise the City Council on items related to the work of the City Auditor and the City's financial statement audits. Among other duties, the Audit Committee shall: Review the Auditor's audit plan annually and submit annually to the City Council; Provide suggestions and comments for the annual audit plan; Review and consult with the Auditor on quarterly reports or updates of the City Auditor's activities and findings; Report irregularities raised by the Auditor to the City Council; Ensure that audit reports are transmitted to the legislative body and to the public; Monitor follow-up on reported findings to assure corrective action is taken by management; Report to the legislative body on problems or problem areas at such times as deemed appropriate; Provide input on, and participate in, the selection of the firm conducting the annual financial statement audits; and Review and forward

to the City Council materials related to the City's annual financial statement audit conducted pursuant to Section 1306 of the Charter.

Membership Requirements: Pursuant to Section 902.2 of the Modesto Charter, the Audit shall be comprised of: (1) The Mayor; (2) Two (2) members of the City Council, who shall be appointed by the Mayor with the advice and consent of the City Council; and (3) Two (2) members of the public who are residents of the City of Modesto and shall possess a minimum of two (2) years of experience in financial or performance auditing. Strong consideration shall be given to residents who are Certified Public Accountants. Such members shall be appointed by the City Council, and may be removed by the City Council.

The mission of the Blight Abatement Advisory Committee shall be to promote public engagement concerning blight abatement in the community and to make recommendations to City regarding program improvements, potential funding opportunities, and support with increasing volunteerism.

BOARD OF BUILDING APPEALS (BBA) (4-Year Term)

The Board of Building Appeals' primary responsibility is to hear appeals from any person questioning an order of the City's Chief Building Official related to building, plumbing, mechanical, electrical, dangerous building or housing codes. Additionally, the Board recommends changes to the building codes as appropriate. The members are appointed, to four-year terms with no limit to the number of terms they may serve.

Section 1102 of the Charter of the City of Modesto authorizes the City Council to appoint members to various Boards and Commissions with the recommendation of the City's Appointments Committee

Membership Requirements: members must be qualified by experience and training to pass upon matters pertaining to building construction.

BOARD OF ZONING ADJUSTMENTS (BZA) (4-Year Term)

The responsibility of the Board of Zoning Adjustment is to uphold the integrity of zoning regulations and the Modesto General Plan. The board makes decisions on applications for conditional use permits, variances and site plans for office development. The Board of Zoning Adjustment also hears appeals concerning decisions made by the Community and Economic Development Department staff.

Membership Requirements: Board Members must be a registered voter in the City of Modesto. Please note that application for this committee requires a financial disclosure statement (Statement of Economic Interests - Form 700) under State law.

CHARTER REVIEW (As Needed)

Section 1604, of the City Charter states the Council shall cause this Charter to be reviewed at least every ten (10) years. The function of the committee is to review Modesto’s City Charter, to ensure it provides the best organization, powers, and functions and essential procedures for the best possible City government.

Membership Requirements: Must be a Resident of the City of Modesto.

CITIZENS’ DISTRICTING COMMISSION (As Needed)

There shall be established a Citizen's Districting Commission, hereinafter "Commission," whose function shall be to recommend to the Council the districts from which Councilmembers shall be elected. The first such Commission shall be appointed by the Council no later than 60 days from the effective date of this Charter provision. The Commission shall meet and recommend to the Council a districting plan establishing six councilmember election districts within nine months of receipt by the City of the final Federal Decennial Census information

Membership Requirements:

- A. Strong consideration shall be given to composing the Commission of:
 - a retired Stanislaus County judge as chairperson;
 - one member from a bona fide local taxpayer's association with tax-exempt status under the relevant provisions of the Internal Revenue Code;
 - one member from a bona fide local nonpartisan political organization, with tax-exempt status under Section 501(c)(3) of the Internal Revenue Code, dedicated to encouraging informed and active participation in government;
 - one member from a bona fide local civil rights organization with tax-exempt status under Section 501(c)(3) of the Internal Revenue Code;

- one member from a former Civil Grand Jury who has served in that role within the previous five years;
 - additional members who have demonstrated civic involvement and a capacity to serve in an honest, independent, and impartial fashion, while upholding public confidence in the integrity of the redistricting process;
- B. The Commission shall reflect the demographic and geographic diversity of the City.
- C. No member of the Commission shall be a relative by blood or marriage within the second degree of the Mayor, a member of the Council, any Charter officer, or any department head or deputy department head.
- D. No member of the Commission shall be an employee of the City nor any bargaining unit for employees of the City, nor be a person who receives compensation from the City or from bargaining units of the City in any manner, including retirement benefits.
- E. No member of the Commission shall be a lobbyist or other person with business before the City that represents an economic interest in excess of the limit for material financial effect as established by local ordinance for the time periods established by local ordinance.
- F. A member of the Commission shall be ineligible for election to the City Council in any district whose boundaries were drawn by the Commission in which he or she serves.
- G. In all other respects, the members of the Commission shall be chosen pursuant to the provisions of this Charter.
- H. Members of the Commission shall serve without compensation.

The committee makes funding recommendations to the Modesto City Council regarding the HUD Community Development Block Grant, Emergency Shelter Grant, and Home Investment Partnership Grant programs.

Please note that application for this committee requires a financial disclosure statement (Statement of Economic Interests - Form 700) under State of California laws.

Membership Requirements: The Citizens' Housing & Community Development Committee shall consist of eleven (11) qualified persons comprised of the following:

CITIZENS' SALARY SETTING COMMISSION (As Needed)

The function of the Citizen's Salary Setting Commission is to recommend compensation for the Mayor and members of the City Council, pursuant to Modesto Municipal Code Section 703(b).

Membership Requirements: Qualified electors residing within the City of Modesto. See Modesto Municipal Code, Section 703(b).

CITIZENS TRANSPORTATION SALES TAX COMMISSION (4-Year Term)

The Citizens Transportation Sales Tax Commission responsibilities are: 1) Reviewing the annual work plan and priorities for revenue derived from any transportation sales tax then in effect; 2) Analyzing and commenting on any proposed items in the City budget that would lessen the City's commitment to road and street funding from sources of revenue other than any transportation sales tax then in effect; 3) Reviewing any policies, standards or similar measures that the City uses to set priorities for where revenues from any transportation sales tax then in effect are to be spent; 4) Reviewing any proposals for the City to use bond or similar financing secured by revenues from any transportation sales tax then in effect; 5) Reviewing any policies, standards or similar measures that the City uses to determine whether work funded by the tax shall be done "in-house" or through outside contracts; and, 6) Reviewing any other matters the Council deems appropriate related to any local transportation sales tax. The Council shall appropriate adequate funds for the work of the Commission.

The Commission consists of 11 members. Strong consideration shall be given to composing the Commission of

- 2 members from any local taxpayer's association with tax-exempt status
- 1 member from any local nonpartisan political organization with tax-exempt status
- 2 members from Modesto Neighborhood Associations or organizations with similar purposes with tax-exempt status
- 1 member from any association representing business such as chamber of commerce
- 1 member from large business located within the City
- 1 member from small business located within the City
- 2 members from labor union with members residing in the City
- 1 member from a former Stanislaus County Civil Grand Jury served within previous five years of appointment

COMMUNITY POLICE REVIEW BOARD (4-Year Term)

The Community Police Review Board (CPRB) is intended to support the needs of the City of Modesto to improve relations between the Modesto Police Department and the community. The CPRB has several unique duties, trainings, meetings, and outreach responsibilities. They conduct monthly public meetings to promote community engagement and to afford the public regular opportunities to provide feedback and receive updates. They review the independent auditor’s annual report and analysis of completed administrative investigations; department use of force incidents; and critical incidents such as officer involved shootings, in-custody deaths and other events resulting in a Major Incident Review. They also prepare and submit an annual report to the City Manager and City Council outlining the CPRB’s activities and any recommendations related to any and all of the CPRB’s review of information including but not limited to officer-involved shootings, use of force and complaints. The CPRB is organized with two officers, a chairperson and a vice-chairperson. The City Manager provides a secretary and staff liaison to support the Board.

Membership Requirements: The board is comprised of nine (9) members who reside within the city limits with preference provided to residents representing diverse ethnicity, gender, sexual orientation, professional experience, organizational affiliations and neighborhoods/districts in Modesto.

CULTURE COMMISSION (4-Year Term)

The Culture Commission is responsible for advising City Council and the City Manager on all matters pertaining to art, literature, music and other cultural activities including the preservation of historic sites, landmarks, documents, paintings and other objects associated with the history of the City.

Membership Requirements: The Commission is made up of 7 members. 5 members must live within the City of Modesto, and 2 members must reside outside of Modesto but within Stanislaus County.

ENTERTAINMENT COMMISSION (4-Year Term)

The Entertainment Commission is responsible for overseeing the entertainment permit process, including dance and processing of special event requests within the City of Modesto. The Entertainment Commission's purpose is to encourage the development of new entertainment businesses as well as assist the organizers and operators to plan and coordinate City services for major events. This will allow the business or event to flourish while meeting the City's public health, safety and welfare needs.

Membership Requirements: Members are required the roles for each position: Business Permit Holder, Non-Profit/Special Event Holder, Board Member/Economic or Tourism Organization, At-large Citizen, Non-Permit holder, Alternate Non-Permit Holder, Event Planning/Marketing Specialist, Alternate Non-Permit Holder, At-large Citizen.

- B. To formulate and recommend policy to the City Council and City Manager in matters that pertain to equity and inclusion, equal opportunity, and disability related issues, to include workforce and services provided to the community.
- C. To review the practices and procedures of the City of Modesto in all matters that relate to equity and inclusion, equal opportunity, and disability, to include workforce and services provided to the community.
- D. To monitor the Equal Employment Opportunity Plan which strives to obtain a City work force which reflects the labor force within the City and Stanislaus County.
- E. To continually review the accomplishments of the City of Modesto in meeting its equity and inclusion goals.
- F. To be updated statistically on complaints and grievances in regard to equal employment opportunity, equity and inclusion, and disability submitted to the City of Modesto.

GOLF COURSES COMMITTEE (4-Year Term - Member)

The Golf Courses Advisory Committee (GCAC) is charged with promoting the game of golf in the Modesto area. The GCAC shall operate as an advisory body for and among organized golf clubs and the general golfing public of the City of Modesto golf Courses; act as a liaison between the general golfing public, golf clubs, and the City's Parks, Recreation and Neighborhoods Department; and shall encourage, promote, and maintain a high standard of sportsmanship among golfers.

Membership Requirements: The GCAC is comprised of 11 members. All members must reside within the City limits, not hold any paid office, employment, or contractor with the City.

- 5 members shall represent organized golf clubs: Muni Niners, SIRS, Modesto Golf Club, Dryden Women's Club, and Creekside Golf Club. The membership of each organized golf club shall recommend one member to represent their respective clubs.

HOUSING REHABILITATION LOAN COMMITTEE (HRLC) (4-Year Term)

The Housing Rehabilitation Loan Committee shall be responsible for reviewing and approving the City of Modesto’s (City) housing rehabilitation loans and grants and for reviewing policy and procedures for the program.

Please note that application for this committee requires a financial disclosure statement (Statement of Economic Interests - Form 700) under State of California laws.

Membership Requirements: The Housing Rehabilitation Loan Committee shall consist of seven (7) qualified persons and one (1) alternate comprised of the following:

LANDMARK PRESERVATION COMMISSION (4-Year Term)

The Landmark Preservation Commission advises City Council on matters related to historic structures and other resources in addition to policies and practices pertaining to preservation of Modesto's landmarks.

Membership Requirements: In order to serve on this commission, an applicant must be a registered voter in the City of Modesto and should have professional skills and/or a demonstrated interest in historical preservation. The voting members should be selected from the following:

- At least one member should be an architect, or if an architect should not be available, an experienced person of the building trades.
- At least one member should be a professional or experienced person in the areas of history, architectural history, archaeology, planning, real estate, design, building trades, landscape architecture or law.

- At least one member should be a person with a background in finance, accounting, appraising or related field.
- At least one member should be a member of the McHenry Museum and Historical Society.
- The other member shall be drawn from persons with a demonstrated interest and/or expertise in historical preservation; and
- One member should also be a member of the Modesto Culture Commission and would serve on both commissions alternatively, a person recommended by the Culture Commission may be appointed by the City Council to serve only on the Landmark Preservation Commission.

MEASURE H OVERSIGHT BOARD (4-Year Term)

The Measure H Oversight Board was established pursuant to the Measure H Sales Tax ordinance (Modesto Transactions and Use Tax Ordinance), codified as Article 12 to Chapter 2 of Title 8 of the Modesto Municipal Code with the voter’s approval of Measure H during General Municipal Election on November 8, 2022. The Oversight Board shall review all revenues and expenditures of funds from the tax authorized by this Ordinance, review annual audit reports related to the tax measure, and make at least one (1) written report to the City Council at a public meeting summarizing the Oversight Board’s findings.

Membership Requirements: The City Council shall appoint a nine (9) -member Oversight Board; Six (6) members from the Council districts with one (1) member being selected as a representative from each Council district and Three (3) “at-large” members chosen from the City as Modesto residents. The Board shall consist of qualified Members that are registered voters, residing within the City and shall be appointed by the City Council by resolution.

The Planning Commission has final authority regarding subdivision maps and parcel maps, certain zoning matters and development plans, and occasionally matters appealed either from the staff level or Board of Zoning Adjustment. The Planning Commission makes recommendations to the City Council regarding annexations, rezonings, code amendments and most General Plan-related matters.

Membership Requirements: Commissioners must be a registered voter in the City of Modesto. Please note that application for this committee requires a financial disclosure statement (Statement of Economic Interests - Form 700) under State law.

3. Promoting the park to various business, corporations and clubs by encouraging them to participate in the actual development of the remaining portions of the master plan and the park.

The primary role of the Tuolumne River Regional Park Citizens Advisory Committee is to act in an advisory capacity to the Tuolumne River Regional Park Joint Powers Agreement (JPA) Commission in matters pertaining to the design, development, enhancement and use of the Park.

The mission of the Modesto Youth Commission is to provide Modesto young people from diverse walks of life with the opportunity to participate actively in the governmental process, to provide advice and input on matters impacting youth, and act as liaison between the youth of Modesto and the City Council on matters affecting the quality of life for all youth.

The Youth Commission has the power and duty to: 1) act in an advisory capacity to the City Council and the City Manager in matters pertaining to youth, and to initiatives, policies and programs impacting the youth in the City of Modesto; 2) formulate and recommend programs to the City Council relating to the concerns and needs of youth in the City of Modesto; promote engagement from nonprofits, neighborhood associations, and other groups to promote and provide better youth services and increase opportunities for youth engagement in the community; 4) work with other youth organizations in the City of Modesto and other communities to share ideas and strategies for increased youth engagement; 5) act in an advisory capacity to other City commissions in matters of youth-related concerns and programs; 6) receive reports from City staff on ongoing efforts and strategies that have been established by the city related to youth activities; and 7) work with City staff to promote better youth services and to find solutions to concerns involving youth in the City of Modesto.

The Youth Commission is comprised of 9 members who live within the boundaries of the City of Modesto and be a full-time student enrolled in high school._
