About the program: Leisure Bucks is a financial assistance program designed to help families afford the cost of enrolling into the City of Modesto's recreation programs. Once qualified, applicants will be given a Leisure Bucks ID card, that is good for up to \$100 toward programs and activities. This program is offered to children under 18, disable-adults, and Senior Citizens whose families are below 80% of the Area Median Income.

New this year: Leisure Bucks have been increased from \$50 to \$100 and there is no longer a 10% payment required at the time of registration. Families are responsible to pay for the cost of any programs in excess of the Leisure Bucks amount.
