INSTRUCTION SHEET

The application must be fully and legibly completed by the person requesting approval for the Daily Alcohol Permit. The application is only for the Modesto Police Department Approval of the permit. **Final approval and licensing** will be done by the State of California, Department of Alcoholic Beverage Control Board.

This license is ONLY available to charitable or non-profit organizations.

The applicant must complete or obtain the following prior to filing this application with the Modesto Police Department:

1. Obtain a City of Modesto Business License (No-charge to non-profit groups)
Location: Finance Department, 2nd Floor, 1010 10th Street, Modesto
2. Obtain a City of Modesto Dance License/Permit (if applicable)
Location: Finance Department, 2nd Floor, 1010 10th Street, Modesto
3. Obtain a Federal Employer ID Number. All charitable or non-profit organizations have or must have this number.
Location: Internal Revenue Service, 1300 K Street, Modesto – 526-7738
4. Obtain a Sellers Permit .

This application **must** be submitted to the Administrative Services Unit, Modesto Police Department, 600 10th Street, Modesto – 572-9679. All the above information **must** be on the application prior to approval/denial by the Modesto Police Department. If the application is approved, the person requesting approval will be notified by phone, and a copy will be mailed to the organization's address. The person requesting approval may also pick up the application in person.
